Dear Ms. Mains,

This FAX replaces the one I sent yesterday, which contained some inadvertent mis-statements connected with the time period of Mr. Roger R. Presseault's tenure as a member of the Social Benefits Tribunal. My apologies for any confusion arising therefrom. **The deadline for you to act as required, noted below, is extended to 2359 hrs. Monday August 13th 2007.**

You will, no doubt, recall my FAX dated June 29th 2007 about this affair, in which I pointed out certain facts which you had previously ignored.

Yesterday I received a letter dated (Tuesday) August 7th from Ms. Carole Sherman, Collection Officer, from the City of Ottawa's Overpayment Recovery Unit. In it, among other things, she says '.....we have no choice but to consider litigation or other debt recovery options to obtain payment from...'

You know perfectly well what has been going on, since my hearing before the Social Benefits Tribunal on January 17 this year. You also know perfectly well what gave rise to it in the first place. Everything was documented and is also documented on my web site.

You have failed to reply in a timely manner to my FAX of June 29th and you refuse to acknowledge the facts therein and all the other facts previously submitted by me. Yet you have not questioned any of the said facts submitted by me.

Further, as you know perfectly well, a current member of your Tribunal – Roger R. Presseault - was partly responsible for creating the situation in the first place. Soon he will be exposed for his part in this scandalous outrage at my expense. Currently his tenure expires in September 2008

The Social Benefits Tribunal is clearly CORRUPT.

YOU WILL THEREFORE INFORM MS. SHERMAN AT THE CITY OF OTTAWA, NOT LATER THAN MONDAY AUGUST 13TH, THAT THE OVERPAYMENT IS CANCELLED.

DO WHAT I TELL YOU, OR I SHALL TAKE ACTION TO HAVE YOU AND EVERYBODY ELSE INVOLVED IN THIS AFFAIR REMOVED FROM YOUR JOBS AND EXPOSED TO PUBLIC CENSURE, WITHOUT FURTHER NOTICE.

Thus far, the persons involved in creating this mess have included at least the following :-

1. Roger R. Presseault – President of federal Board of Referees in Ottawa, in 1995; now a Member of the Social Benefits Tribunal

2. Jonathan P. Langsner – Legal Services Department, H.R.D.C., in 1996, now with federal Justice Department
3. H. Buckley-Routh – Presiding Member, Social Benefits Tribunal
4. Roslynn Mains – Presiding Member, Social Benefits Tribunal
5. Mr. R. Fox, City of Ottawa – Case Presenting Officer
6. Ms. Carole Sherman, City of Ottawa Overpayment Recovery Unit.

This whole affair, from the beginning in 1994 right up to now, has involved a combination of mis-information and sloppy legal work on the part of everybody involved.

This has involved a totally counter-intuitive and flawed approach in which everybody involved has been attempting to hide behind “the law” (if you can call it that) in order to pretend that the facts do not exist, so as to (a) prevent me from getting back to work, and (b) “justify” an attempt to prosecute a stupid little legal “case” against me - just to make work for certain highly-paid lawyers, members of the judiciary and others acting in a judicial or quasi-judicial capacity.

In short , a “sloppy bang-up job” throughout, by all concerned.

You are to cease and desist from this behaviour at my expense at once. You have been warned; no further warning will be given.

The so called “ overpayment ” for which you are pursuing me is to be cancelled at once.
